SHOW CAUSE NOTICE

In terms of Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the (Southern Regional Committee) of NCTE granted recognition to (Sri Devraj URS D.Ed College) for conducting (D.El.Ed.) vide recognition Order No. **3731** dated **11.08.2008** with annual intake of **50** students.

2. AND WHEREAS, the matter of non-submission of Performance Appraisal Report ("PAR") by the Institution for academic session 2021-22 was considered by the **Southern Regional Committee** in its meeting no. 456 held on 26.03.2025 and the Committee observed and decided as under:

1. "Under Section 12 (k) of the NCTE Act, 1993, the following is mandated as one of the functions of the Council:

(k) evolve suitable performance appraisal system, norms and mechanism for enforcing accountability on recognised institutions;"

2. In view of the above provision, in the **61st General Body Meeting** held on **05.08.2024**, the agenda for consideration and approval of online Performance Appraisal Report (PAR) module for submission of Performance Appraisal Report (PAR) for the Academic Session(s) 2021-22 & 2022-23 and other related documents by the Recognized Teacher Education Institutions was placed before the Council.

3. The Council deliberated on the agenda in detail and approved the following:

I. "Online PAR Module which is to be filed by the recognised institutions.

II. Replica of the Online PAR Module

III. General Instructions for filling up the PAR


IV. Public Notice for the recognised institutions to submit PAR for the Academic Session(s) 2021-22 & 2022-23

V. Format of certificate to be obtained from the affiliating body by the institution concerned that the institution is affiliated to it and is following all the Norms and Standards of NCTE for Course Recognized by NCTE.

.....Apart from the above, the Council Authorized the Chairperson, NCTE to decide the timeline for submission of PAR by the recognized TEIs and for any further alteration and deletion in the Online PAR Module as per requirement for the aforesaid and subsequent academic session(s)"

4. In pursuance of the decision taken by the Council in 61st **General Body Meeting** held on **05.08.2024**, a Public Notice dated 09.09.2024 was issued that required all the recognised Teacher Education Institutions (TEIs) to submit Performance Appraisal Report (PAR) for academic session(s) 2021-22 and 2022-23 on the online NCTE portal. The deadline to submit PAR was 10.11.2024 and the same was further extended to 10.12.2024 and subsequently to 31.12.2024 vide public notice dated 7.11.2024 and 10.12.2024 respectively.
5. In addition to the public notices, multiple attempts through press releases, regular reminders and video messages of both the Chairperson and Member Secretary of NCTE, uploaded across all major social media platforms with complete guide/tutorial for filling PAR were made to spread awareness and sensitize all the recognized teacher education institutions to for timely submission of their PAR.

Further to the above the Southern Regional Committee has deliberated upon the above and observed that despite the grant of multiple extensions, adequate opportunities and fair chance by the Council, your institution has not submitted the Performance Appraisal Report (PAR) for academic session 2021-22 of D.El.Ed. course. Thus, the Southern Regional Committee has decided to issue a Show Cause Notice under Section 17(1) of the NCTE Act, 1993, as to why action of withdrawal of recognition should not be initiated against your institution on account of non-submission of the Performance Appraisal Report (PAR) for the academic session 2021-22"



3. In view of the above facts and decision taken by the Southern Regional Committee, you are hereby directed to show cause as to why action of withdrawal of recognition under Section 17(1) of the NCTE Act, 1993, should not be initiated against your institution on account of non-submission of Performance Appraisal Report (PAR) for the academic session 2021-22 of D.El.Ed. course. Your reply should be submitted within a period of 15 days from the date of issuance of this Show Cause Notice on the NCTE Online Portal. (https://par.ncte.gov.in/par_feedback_system/)
